Our letter to your attention dated October 3, 2013 is hereby rescinded.

The State of Idaho would like to renew the above referenced contract for a period of Two (2) Years (which period coincides with the period of renewal of the state of Washington Master Agreement number 01611; see attached document).

The contract renewal period is <u>October 31, 2013 to October 30, 2015</u>. The same terms, conditions and prices prevail for the contract renewal period, except as expressly modified herein.

- 1. Upon the effective date of the renewal (October 31, 2013), PADD1092 is amended (modified) as follows:
 - a. See PADD1092, subsection 2, Changes. All information beginning with the heading "<u>Idaho</u> <u>Administrative Reports</u>" through the end of the section is hereby deleted and replaced by the following:

"Idaho Administrative Fee

Administrative Fee:

The prices to be paid by the procuring agency shall be <u>inclusive of</u> a one and one-quarter percent (1.25%) agency Participating Addendum (contract) usage Administrative Fee. This additional percentage represents the procuring agency's contract usage Administrative Fee. On a quarterly basis, Contractor will remit to State of Idaho, Attn: Division of Purchasing, PO Box 83720, Boise, Idaho 83720-0075 an amount equal to one and one-quarter percent (1.25%) of Contractor's net (sales minus credits) quarterly sales under the contract. The State of Idaho understands and agrees that Contractor may raise the negotiated Master Price Agreement prices by this amount.

For Example: If the total of your net sales to the all procuring agencies for one quarter = \$10,000, you would remit $$10,000 \times 0.0125 = 125 to the Division of Purchasing for that quarter, along with the required quarterly usage report.

The following are authorized Purchasing Entities under this Participating Addendum: All state governmental entities within the State of Idaho and public agencies (as defined by Idaho Code, section 67-2327) are hereby authorized to purchase products and services under the terms and conditions of the WSCA master Price Agreement number 01611. These public agencies include any city or political subdivision of the State of Idaho, including, but not limited to counties, school districts, highway districts, port authorities, instrumentalities of counties, cities, or any political subdivision created under the laws of the State of Idaho, and public schools and institutions of higher education. It will be the responsibility of the public agency to independently contract (i.e. issue purchase orders) with the contractor and/or comply with any other applicable provisions of Idaho Code governing public contracts.

2. Changes:

Parties to this Participating Addendum: The parties to this Participating Addendum (PA) are MPH Industries, Inc. (Contractor) and the State of Idaho by and through this statutory agent, the Division of Purchasing within the Department of Administration (State) on behalf of the entities identified in the titled "scope" of this Participating Addendum (procuring Agencies).

Applicable Law: Notwithstanding (Order of Precedence) the WSCA Master Price Agreement number 01611, Terms and Conditions are supplemented with the following which shall apply to this PA:
