1.1 Scope:

This PA includes the entire scope of the products and services available through the Master Agreement referenced above.

Emergency Rental Needs: In the event the Contractor does not have a rental store within

sixty (60) miles of the Purchasing Entity's location at the time of an emergency need, the Purchasing Entity reserves the right to purchase rent equipment from a different vendor. Emergency Need is defined as an event that requires attention within a 24-hour period or sooner.

Any scope exclusions specified herein apply only to this PA and shall not amend or affect other participating addendums or the Master Agreement itself.

Except as expressly modified in this Amendment, all other terms and conditions of the Contract remain in full force and effect.

2. This Amendment is effective upon the date of the last signature below. In no event will this Amendment be effective until executed by the Department of Administration.
