Recitals

1. The Parties entered into a Contract (SBPO20220924) for Plain and Printed Envelopes for the State of Idaho, effective August 12, 2021.
2. The Contract was renewed August 2022.
3. The Contract had amendment #1 take place January 2022 for a ten percent (10%) price increase and Amendment 2 take place August 2022 for a price increase and renewal.
4. The Parties desire to renew the contract for the 2023-2024 term and add a specialized envelope with pricing (Schedule V).
5. The Idaho Legislature has created Idaho Code section 67-2359 requiring a certification by the Contractor.

Agreement

Based on the above recitals, and good and valuable consideration, the receipt of which is hereby acknowledged, the Contract is amended as follows:

1. The Contract is renewed from August 12, 2023, to August 11, 2024.
2. This amendment adds Schedule V as follows:
