Recitals

- 1. The Parties entered into a Contract SBPO19200436 for Practice Ammunition for the State of Idaho, effective 4/8/2019.
- 2. This Contract has been renewed previously 4 times with price changes each year.
- 3. With this Amendment No. 5, the Parties desire to renew the Contract for 1 year, update pricing, and incorporate certifications required by Idaho Code, as further detailed below.

Agreement

Based on the above recitals, and good and valuable consideration, the receipt of which is hereby acknowledged, the Contract is amended as follows:

- 1. The Contract is renewed from April 8, 2025, to April 7, 2026.
- 2. The pricing for all line items is hereby removed and replaced with the pricing in *Exhibit A Updated*, attached herein below.

- 3. The following certifications are added to the Contract:
 - 3.1 <u>Boycott of Israel.</u> Pursuant to Idaho Code section 67-2346 (effective July 1,2021), if payments under the Contract exceed one hundred thousand dollars (\$100,000) and Contractor employs ten (10) or more persons, Contractor certifies that it is not currently engaged in, and will not for the duration of the Contract engage in, a boycott of goods or services from Israel or territories under its control. The terms in this section defined in Idaho Code section 67-2346 shall have the meaning defined therein.
 - 3.2 <u>Boycott of Various Industries.</u> Pursuant to Idaho Code section 67-2347A (effective July 1, 2024), if payments under the Contract exceed one hundred thousand dollars (\$100,000) and Contractor employs ten (10) or more persons, Contractor certifies that it is not currently engaged in, and will not for the duration of the Agreement engage in, a boycott of any individual or company because the individual or company: (a) engages in or supports the exploration, production, utilization, transportation, sale, or manufacture of fossil fuel-based energy, timber, minerals, hydroelectric power, nuclear energy, or agriculture; or (b) engages in or supports the manufacture, distribution, sale, or use of firearms. The terms in this section defined in Idaho Code section 67-2347A shall have the meaning defined therein, including through reference to another section of Idaho Code.
- 4. Except as expressly modified in this Amendment, all other terms and conditions of the Contract remain in full force and effect.
- 5. This Amendment is effective upon the date of the last signature below. In no event will this Amendment be effective until executed by the Department of Administration.
