
C. This Amendment is required due to price changes under the Master Price Agreement.





1. Upon the effective date of the renewal (October 31, 2013), PADD1093 is amended (modified) as follows:

"Idaho Administrative Fee

Administrative Fee:

The prices to be paid by the procuring agency shall be inclusive of a one and one-quarter percent (1.25%) agency Participating Addendum (contract) usage Administrative Fee. The state may treat violation of the clause as an event of default."




