Orders: Any Purchase Order placed by a Purchasing Entity for a Product and/or Service available from this Master Agreement shall be deemed to be a sale under (and governed by the prices and other terms and conditions) the Master Agreement unless the parties to the Purchase Order agree in writing that another contract or agreement applies to such Purchase Order.
- 7. <u>Website Ordering:</u> Neither Central Lake Armor Express, dba Armor Express nor any of its Distributors are authorized to allow Purchasing Entities to place orders via any website.
- 8. <u>Lease Agreements:</u> A lease agreement has not been approved for use for procuring agencies within the state of Idaho.
- 9. <u>Applicable Terms:</u> The Participating Entity agrees to the terms of the Master Agreement only to the extent the terms are not in conflict with this PA or with applicable law.
- 10. <u>Records Maintenance</u>: The Contractor shall maintain or supervise the maintenance of all records necessary to properly account for all payments made to the Contractor for the costs authorized by the PA. These records shall be retained by the Contractor for at least three (3) years after the PA terminates, or until all audits initiated within the three (3) years have been completed, whichever is later.
- 11. <u>Term:</u> The initial term of this PA will be effective upon execution by the parties and continue through March 15, 2018, with the option to renew upon mutual, written agreement between the parties for up to three (3) consecutive one (1) year terms.
- 12. Entire Agreement: This PA and the Master Agreement together with its exhibits, set forth the entire agreement between the parties with respect to the subject matter of all previous communications, representations or agreements, whether oral or written, with respect to the
