Recitals

1. The Parties entered into a Contract (PADD20210619) for Wireless Voice, Data, and Accessories for the State of Idaho, effective March 30, 2021.
2. With this Amendment No. 1, the Parties desire to renew the contract, and obtain Contractor certification of Idaho Code 67-2359, and Idaho Code 67-2347A as further detailed below.

Agreement

Based on the above recitals, and good and valuable consideration, the receipt of which is hereby acknowledged, the Contract is amended as follows:

1. The term of the Contract is renewed for five (5) years from August 12, 2024, August 11, 2029. The estimated value of the renewal period is \$2,000,000.00.
2. Pursuant to Idaho Code 67-2347A (effective July 1, 2024), if payments under the Contract exceed one hundred thousand dollars (\$100,000) and Contractor employs ten (10) or more persons, the Contractor certifies that it is not currently engaged in and will not for the duration of the Agreement, engage in a boycott of any individual or

company because the individual or company: (a) engages in or supports the exploration, production, utilization, transportation, sale, or manufacture of fossil fuel-based energy, timber, minerals, hydroelectric power, nuclear energy, or agriculture; or (b) engages in or supports the manufacture, distribution, sale, or use of firearms. The terms in this section defined in Idaho Code section 67-2347A shall have the meaning defined therein, including through reference to another section of Idaho Code.

3. Pursuant to Idaho Code 67-2359, the Contractor certifies that it is not currently owned or operated by the government of China and will not for the duration of the Contract be owned or operated by the government of China.
4. Except as expressly modified in this Amendment, all other terms and conditions of the Contract remain in full force and effect.
5. This Amendment is effective upon the date of the last signature below. In no event will this Amendment be effective until executed by the Department of Administration.
