1. The Parties entered into a Contract (SBPO15200473) for Switched, Long Distance for Idaho Public Agencies, effective August 5, 2019.
2. This Contract has had 9 renewals.
3. The Contract was amended on November 27, 2023, via Amendment No. 1, which renewed the Contract for 13 months.
4. Amendment No. 2, extended the Contract for one (1) year on January 1, 2025.
