- 1. The Parties entered into a Contract (SBPO17200384) for Statewide Bulk Fuel for The State of Idaho, effective 12/29/2016.

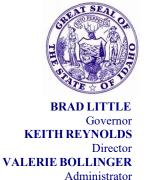

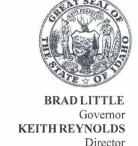
