1. The Parties entered into a Contract (SBPO17200384) for Statewide Bulk Fuel for The State of Idaho, effective 12/29/2016.
2. The Contract was renewed on 11/29/2017, 11/29/2018, 11/29/2019, 11/29/2020, 11/29/2021 all for one-year periods.
