1. The Parties entered into a Contract (SBPO19200189) for Facilities MRO for the State of Idaho, effective October 22, 2018.
2. The Contract was amended on September 24, 2021, via Amendment No. 1, which renewed the Contract for a two-year period, from October 22, 2021, to October 20, 2023
3. The Contract was amended on August 4, 2023, via Amendment No. 2, which extended the Contract from October 22, 2023, to June 30, 2024.
4. The Contract was amended on June 17, 2024, via Amendment No. 3, which extended the Contract for three (3) months.

The terms in this section defined in Idaho Code section 67-2347A shall have the meaning defined therein, including through reference to another section of Idaho Code.
3. Except as expressly modified in this Amendment, all other terms and conditions of the Contract remain in full force and effect.
4. This Amendment is effective upon the date of the last signature below. In no event will this Amendment be effective until executed by the Department of Administration.
