1. The Parties entered into a Contract (SBPO19200191) for Facilities MRO for The State of Idaho, effective October 22, 2018.
2. The Contract was amended on October 21, 2020, via Amendment No. 1, which extended the Contract for one (1) year.
3. The Contract was amended on October 21, 2021, via Amendment No. 2, which extended the Contract for eight (8) months.
4. The Contract was amended on May 6, 2024, via Amendment No. 3, which extended the Contract for three (3) months.

Pursuant to Idaho Code section 67-2347A (Effective July 1, 2024), if payments under the Contract exceed one hundred thousand dollars (\$100,000) and Contractor employs ten (10) or more persons, Contractor certifies that it is not currently engaged in, and will not for the duration of the Agreement, engage in, a boycott of any individual or company because the individual or company: (a) engages in or supports the exploration, production, utilization, transportation, sale, or manufacture of fossil fuel-based energy, timber, minerals, hydroelectric power, nuclear energy, or agriculture; or (b) engages in or supports the manufacture, distribution, sale, or use of firearms. The terms in this section defined in Idaho Code section 67-2347A shall have the meaning defined therein, including through reference to another section of Idaho Code.
3. Except as expressly modified in this Amendment, all other terms and conditions of the Contract remain in full force and effect.
4. This Amendment is effective upon the date of the last signature below. In no event will this Amendment be effective until executed by the Department of Administration.

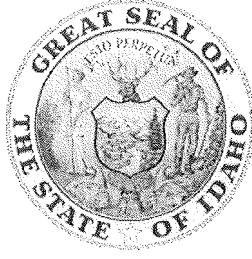
