Recitals

1. The Parties entered into a Contract (SBPO20220917) for Statewide Propane Fuel and Related Equipment (Zones 3, 4, 5, & 6) for Idaho Public Agencies, effective August 11, 2021.
2. The Contract was amended on December 12, 2021, via Amendment No. 1, which added a new location in Zone 3.
3. The Contract was renewed on August 11, 2022, for a one-year period.
4. The Contract was amended on August 7, 2023, via Amendment No. 2, which renewed the Contract.
5. The Contract was amended on July 29, 2024, via Amendment No. 3, which renewed the contract and added funds.
6. The Contract was amended on June 24, 2025, via Amendment No. 4, which renewed the contract and added funds.
7. The Contract was amended on December 15, 2025, via Amendment No. 5, which added Twin Peaks State Park as a delivery location.
8. The Contract was amended on June 8, 2026, via Amendment No. 6, to add a delivery location.

9. With this Amendment No. 7, the Parties desire to extend the Contract for three (3) months, as further detailed below.

Agreement

Based on the above recitals, and good and valuable consideration, the receipt of which is hereby acknowledged, the Contract is amended as follows:

1. The Contract is extended for three (3) months, from August 10, 2026, to November 30, 2026. The estimated value of the extension period is \$84,000.00.
2. Except as expressly modified in this Amendment, all other terms and conditions of the Contract remain in full force and effect.
3. This Amendment is effective upon the date of the last signature below. In no event will this Amendment be effective until executed by the Department of Administration.
