**Recitals**

1. The Parties entered into a Contract (SBPO20231549) for IT Security Products for the State of Idaho, effective January 30, 2023.
2. The Contract was renewed on January 30, 2024 (Amendment 1).
3. With this Amendment No. 2, The Parties desire to renew the Contract, and incorporate additional terms and conditions as required by Idaho code, as further detailed below.

**Agreement**

Based on the above recitals, and good and valuable consideration, the receipt of which is hereby acknowledged, the Contract is amended as follows:

1. The Contract is renewed from January 30, 2025, to January 29, 2026. \$100,000.00 is added to the Contract.
2. The following terms and conditions are added to the Contract:
  - 2.1 Pursuant to Idaho Code section 67-2347A (Effective July 1, 2024), if payments under the Contract exceed one hundred thousand dollars (\$100,000) and Contractor employs ten (10) or more persons, Contractor certifies that it is not currently engaged in, and will not for the duration of the Agreement, engage in, a boycott of any individual or company because the individual or company: (a) engages in or supports the exploration,

production, utilization, transportation, sale, or manufacture of fossil fuel-based energy, timber, minerals, hydroelectric power, nuclear energy, or agriculture; or (b) engages in or supports the manufacture, distribution, sale, or use of firearms. The terms in this section defined in Idaho Code section 67-2347A shall have the meaning defined therein, including through reference to another section of Idaho Code.

3. Except as expressly modified in this Amendment, all other terms and conditions of the Contract remain in full force and effect.
4. This Amendment is effective upon the date of the last signature below. In no event will this Amendment be effective until executed by the Department of Administration.
