### Recitals

1. The Parties entered into a Contract (5856) for Statewide Bulk Fuel Zone 3 Unleaded Fuel and 1 & 2 Dyed Diesel for Idaho Public Agencies, effective July 1, 2024.
2. The Contract was amended on April 8, 2025, via Amendment No. 1, which added funds and renewed the contract.
3. With this Amendment No. 2, the Parties desire to renew the contract, and add funds, as further detailed below.

### Agreement
