How to Place an Order

An Agency placing an order for the first time must provide its point-of-contact, address of delivery location, existing tank(s) and any other pertinent information to the Contractor for invoicing. The Agency's failure to provide the information will suspend any order(s) to that Agency until Contractor has received the correct information for billing.

Ordering Quantity

Ordering Agencies must place orders for propane fuel of a minimum of one hundred (100) gallons, unless Contractor agrees to deliver a lesser quantity. Quantities with a capacity of less than one hundred (100) gallons may have to be transported by the Ordering Agency to a Contractor's refilling location to be filled. No maximum quantities shall be established, and the Contractor must fulfill any quantities greater than the established minimum.

Prices

The price paid by Ordering Agencies, for propane, must be the amount from the Butane-Propane News (BPN) US Resellers Propane Prices, FOB terminal (Midstream Energy; San Joaquin Valley, CA) PLUS Contractor's "Mark-up Price."

Price Adjustment Clause

All contract prices will be adjusted weekly and based solely on the rack and reseller price, exclusive of freight, taxes and special discounts, for US Resellers Propane Prices, FOB terminal (Midstream Energy; San Joaquin Valley, CA) as reported in the BPN weekly publication. The effective date of the price change will be the Friday following the date of the latest BPN publication.
